If you intend to build a vessel outside of the EN-13121 standard, then Amphora will not be applicable for the design process. For guidance on the limitations of Amphora, please contact the Amphora admin.

In certain cases, the EN standard does not provide a guideline. For these cases where the EN 13121 standard is not clear or is lacking, we have made the following additions:

- 1. Kr-factor in combination with a conical bottom
- 2. Effective width of stiffener at the concentrated support points
- 3. Load distribution at concentrated support points

These additions are based on years of professional engineering experience, research and numerical analysis in the design of silos and storage vessels.
